### LIMITED PRODUCT WARRANTY FOR DESERT BRAND PRODUCTS

Hill Brothers warrants all Desert Brand products to be of merchantable quality, free from manufacturing defects, and to conform to product specifications as defined by Hill Brothers/Desert Brand. This limited warranty is valid only when these products are applied in strict accordance to label directions, the most current application specification document or Technical Bulletin, including any substrate and weather conditions, or any other application conditions listed in the aforementioned documents. Hill Brothers does not warrant these products for uses other than those listed on the label or any Desert Brand application specification documents or Technical Bulletins.
